

Missing alternative text for images

CRITICAL (19 total)

Why this matters

Images without alternative text are not conveyed to screen reader users. Users may miss information that is communicated visually.

Links without discernible text

SERIOUS (27 total)

Why this matters

Links without accessible names are difficult to use with assistive technologies. Users may not understand link purpose or be unable to navigate effectively.

Buttons without accessible names

CRITICAL (11 total)

Why this matters

Buttons without accessible names are ambiguous or unusable for screen reader users. Users may not know what a button does or may be unable to operate controls.

Incorrect heading order

Why this matters

Heading structure is used by assistive technologies to understand and navigate content. Users may have difficulty skimming pages and understanding page structure.

- Ensure heading levels progress logically (H1 > H2 > H3, etc.).
- Use headings for structure, not styling.

METHODOLOGY & LIMITATIONS

The following methodology was used to produce this evidence artefact. Results are subject to the limitations noted below.

Methodology, Scope & Limitations

- Automated accessibility testing using axe-core with WCAG 2.0/2.1 Level A and AA criteria.
- Same-origin, breadth-first crawl starting from the supplied URL.
- Maximum 300 pages scanned, 30-second per-page axe timeout, 60-minute hard runtime cap.
- JavaScript rendering enabled in headless Chromium.
- Automated testing cannot detect all accessibility issues; manual review remains necessary.
- Results reflect a point-in-time assessment and may change as the site changes.

Reproducibility Notes

- The scan is deterministic within the crawl policy and runtime caps.
- Evidence sampling caps may apply; full reproduction may yield additional occurrences.



SEVERITY OVERVIEW

A total of 22 distinct issue types were identified, with 209 individual occurrences across all scanned pages. The distribution by severity level is shown below.
























Evidence 12: button-name (critical)


